The District will consider and act upon the following matters:

2. To receive public comment.
3. To approve the Minutes of prior meeting(s).
4. To canvass the results of the November 5, 2024 election.

5. To review and act on financial matters, including financial report, investments, accounts, depository security, lines of credit, resolutions for account access, and to pay bills.
6. To review and act on amendments/revisions to District budgets.

7. To review and take action to approve the purchase of capital assets, including apparatus/vehicles, equipment, tools and communications equipment.
8. To review and act on disposition of surplus and/or salvage property.
9. To review and act on District obligations, including retiring obligations or incurring obligations for construction, real estate, vehicles and equipment.
10. To receive a report from Fire Chief on Fire Department activity.
11. To review, discuss and act on any issues related to the repairs, improvement, and construction of District facilities, including engaging construction services, change orders and construction payments.
12. To review and take action on the ratification of a continuing Contract with a private law firm pursuant to §6.30 of the Tax Code for the collection of delinquent District ad valorem property taxes and providing for the payment of up to 20% of the delinquent taxes, penalties, and interest which are collected by the attorney under said Contract.
13. To discuss and take action on the imposition of additional penalty on delinquent taxes pursuant to §33.07 of the Tax Code and adoption of a Resolution regarding same for taxes.
14. To discuss and take action on the imposition of additional penalty on delinquent taxes to defray costs of collection by the District's delinquent tax attorney, pursuant to §33.08 of the Tax Code and adoption of a Resolution regarding same.
15. To discuss and take action on the imposition of early additional penalty for collection costs for taxes imposed on personal property on delinquent taxes pursuant to §33.11 of the Tax Code and adoption of a Resolution regarding same.
16. To review and act on personnel matters, including action on hiring, retention, policies, duties, and benefits.
17. To review and act on real estate, including but not limited to purchase, sale, platting, or permits.
18. To review and act on any matters regarding dispatch, communications or mutual aid agreements with other agencies.
19. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
20. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
21. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
22. To review, discuss and take action regarding matters discussed in the Closed Session.
23. To set the date of the next regular meeting and address any additions to the agenda.
